- Consider proposal to delay launch of Early Bird Registration to end of April when we currently plan to launch the call for proposals
  - Eventbrite takes some of the registration fees off of the top of registration so need to discuss this next year
  - Delaying registration should not impact finances so suggestion is to delay launch of early bird registration until we launch the call for proposals in April
- Discuss IEHE partnership
  - Message to CAIR listserv
  - Discussed resources and producing list of resources to share with CAIR community
- Discuss March and April messaging to CAIR listsery and to sponsors
  - Discussed ways to communicate resources and updates to our CAIR community
  - Discussed idea of a 'Town hall' type meeting and what that looks like. Committee formed:
    - Rosa, Andrew, Roop, Monica and Cheryl to help ferret out this idea and work on how this can be done.
  - Discussed messaging title and content with regards to promotion of the new CAIR website launch and how to ensure that is out to our members as well

- Committee approved language in the message to the CAIR listserv
- Andrew Update on proposals.
- (added 3/24) Discuss decision points and timelines for possibility of canceling 2020 conference
  - Is this financially feasible if we are able to have some version of the conference? (Todd would likely be able to renegotiate our contract given the situation, though this may require a rebook clause)
    - Given all of the unknowns with things going on, and not knowing if campuses will send attendees, can we have a conference this year?
    - What would renegotiate the contract look like? Maybe 3 concurrent sessions instead of 8? How can we scale back? N
    - Rebook clause if we say we will rebook in 2022, will they be more amenable to downsizing the conference this year?
    - Decision points will be when sponsorships and proposals roll in.
    - Discussed likelihood of people being able to attend and sending a survey to ask how many will likely be able to attend. When should we survey and ask?
    - Discussed reaching out to Todd and the hotel to come up with options for if the conference has to be cancelled. So much is currently unknown so it is hard to say if we can have a conference this year and what that would look like.
    - Discussed insurance for CAIR. Do we have it? What is it?
